1). PLEASE LET US KNOW THE EXACT TIME THAT EVERYONE IN YOUR BRIDAL PARTY NEEDS TO BE COMPLETELY DONE BY. THIS TIME IS IMPARTIVE IN OUR SCHEDULING PROCESS. Based on this time, we will determine the time that our team needs to start the makeup process. This time is based on years of experience; unforeseen circumstances can and do often arise and it is better to have more time than to run out of time. My number one goal is having our Bride be stress-free and at ease during this process!

2). Once I have set a specific start time for your services, I ask that you please not arrive late. Late arrival times interfere with our goal to have everyone ready on time. If you feel that there may be issues with the designated start time, please contact me as soon as possible.

3). Please bring any pictures you have of makeup styles that you like with you to your trial or day-of services. Please try to have in mind a style for makeup that you like, if not *DO NOT STRESS...* I will help you!!

4). It is the responsibility of the Bride to communicate all of this information to the wedding party. Things will always run more smoothly if everyone is on the same page and aware of all of this information beforehand.
